Notice is hereby given that a majority of the City of Lodi Common Council may be present at a meeting of the Public Works

& Utilities Committee to gather information about subjects over which they have decision making responsibility. This constitutes a meeting of the city council pursuant to State ex rel. Badke v. Greendale Village Bd., 173 Wis.2d 553, 494 N.W.2d 408 (1993), and must be noticed as such; although the City of Lodi Common Council will not take any formal action at this meeting.

§ 325-3 **Parking, stopping and standing regulated.**

A. Parking limits. ~~City of Lodi vehicles, or vehicles directly performing maintenance for the City, are exempt.~~

- (1) No Parking. No person shall park or leave standing at any time any vehicle, trailer, boat, or similar item on the following streets and alleyways:
 - (a) Alleyways, described as follows:
 - (i) From Ellie Rae Drive to Fieldstone Drive
 - (ii) From Fieldstone Drive to Cobblestone Drive and Ellie Rae Drive
 - (b) Nestles Street, from the intersection of Water Street/Hwy 60 to a point 350 feet north.
 - (c) North Main Street, from Gay Street North.
 - (d) Parr Street, from Portage Street/Hwy 60 to Millston Avenue.
 - (e) Sodders Street, from South Main St/Hwy 113 to Spring Street.
- (2) Limited No Parking.
 - (a) School Zone Parking. No person shall park or leave standing at any time any vehicle, trailer, boat, or similar item, Monday through Friday from 7:30 a.m. to 3:30 p.m.
 - (i) Millston Avenue, from Fair Street to Parr Street on the north side of the street.
 - (ii) Sauk Street, from the west intersection of Meadowview Lane to Ottowynn Terrace.
 - (iii) Valley Drive, from Sauk Street to Prairie Stone Drive.
 - (b) City Library Parking. Parking in the City Library lot is restricted to patrons and employees during regular business hours.
- (3) One-sided parking. No person shall park or leave standing at any time any vehicle, trailer, boat, or similar item on the following streets:
 - (a) Davis Street on the north side of the street.
 - (b) Downey Street on the west side of the street.
 - (c) Gay Street on the west side of the street.
 - (d) Hill Street on the east side of the street.
 - (e) Millston Avenue on the south side of the street, from Fair Street to Parr Street.
 - (f) North Main Street on the east side of the street north of Fair Street except in designated parking stalls.
 - (g) Portage Street on the southeast side of the street, from Spring Street to Clark Street.
 - (h) Ryan Street on the east side of the street.
 - (i) Water Street on the west and ~~south~~-north side of the Street.

(45) Fifteen-minute parking:

(a) Such stalls as are so marked on First Street.

B. Street storage and other parking limitations.

(1) No person or persons shall permit any vehicle, trailer, boat, or similar item to be parked or left standing between the hours of 3:00 a.m. and 5:00 a.m. on:

(a) Main Street, between its intersection with Columbus Street and its intersection with First Street;

(b) Portage Street between its intersection with Spring Street and its intersection with Main Street;

(c) Lodi Street between its intersection with Main Street and its intersection with Prairie Street.

(2) No person shall park or leave standing any vehicle, trailer, boat, or similar item for a period longer than 48 consecutive hours on any street, highway, or public parking lot in the City of Lodi, excluding weekends and the following holidays: New Year's Day, Memorial Day, July 4th, Labor Day, Thanksgiving Day, and Christmas Day ~~(unless permission has been obtained from the Lodi Police Department).~~

(3) It shall be unlawful for the operator of any vehicle, trailer, boat, or similar item to park in any space or stall appropriately marked "No Parking."

(4) All vehicles, trailers, boats, or similar items shall be parked parallel to the curb or tree bank except on such streets where angle parking spaces are so designated and so provided by appropriate markings.

(5) (Reserved)

C. Commercial vehicle parking in residential areas. None of the following shall be parked or stored in any area of the City which is zoned residential except when loading, unloading, or rendering a service:

(1) ~~Truck~~ ~~Semi-truck~~ tractors and/or ~~semi-truck trailers~~ ~~semitrailers~~ as defined in, Wis. Stats., ~~except that truck tractors are permitted to be~~ ~~parked in residential districts for a period not to exceed four hours during daylight hours while being~~ ~~cleaned.~~

(2) Other commercial motor vehicles or trailers over 12,000 pounds' licensed gross weight ~~which are~~ ~~designed or used for~~ ~~commercial purposes~~, including school buses.

~~(3) Trailers designed or used for commercial purposes.~~
D. Exemptions and/or Exceptions

(1) City of Lodi vehicles, or vehicles directly performing maintenance for the City, are exempt.

(2) When permission has been granted by the Lodi Police Department.
