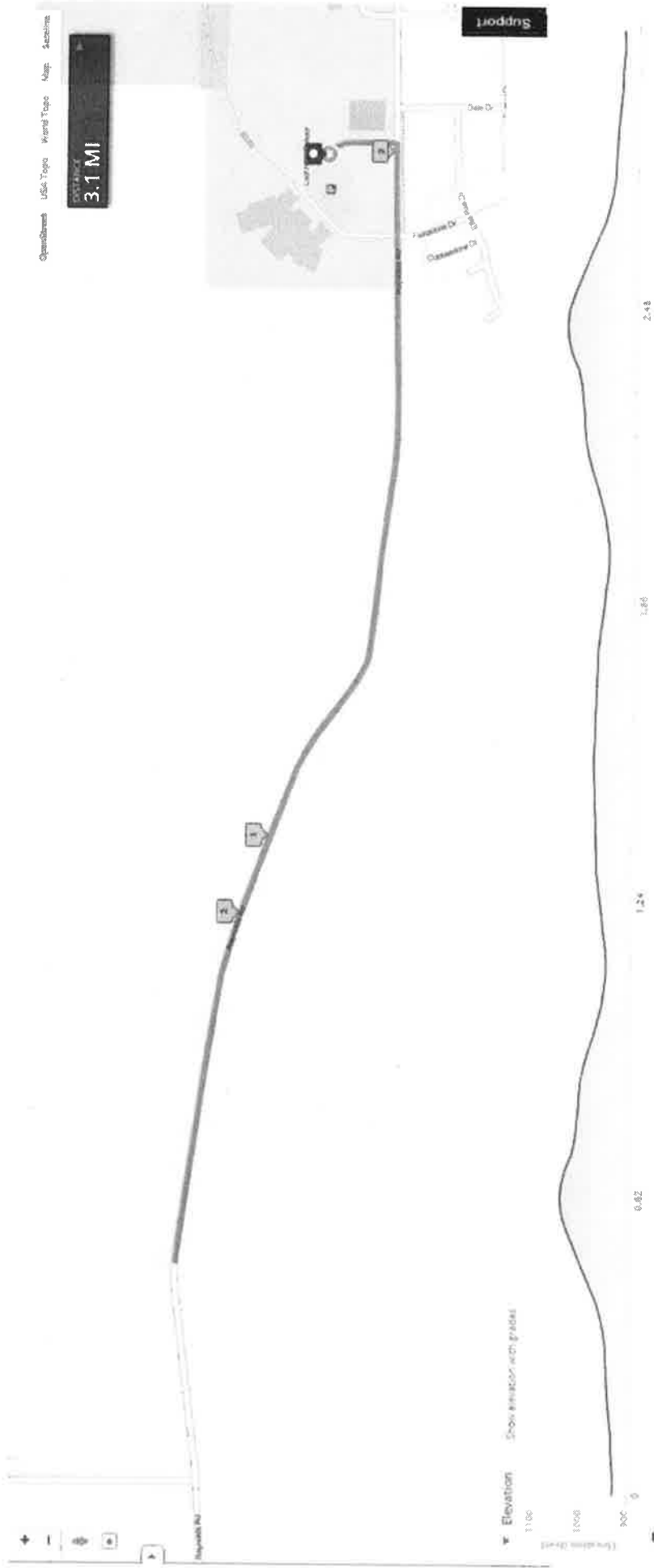

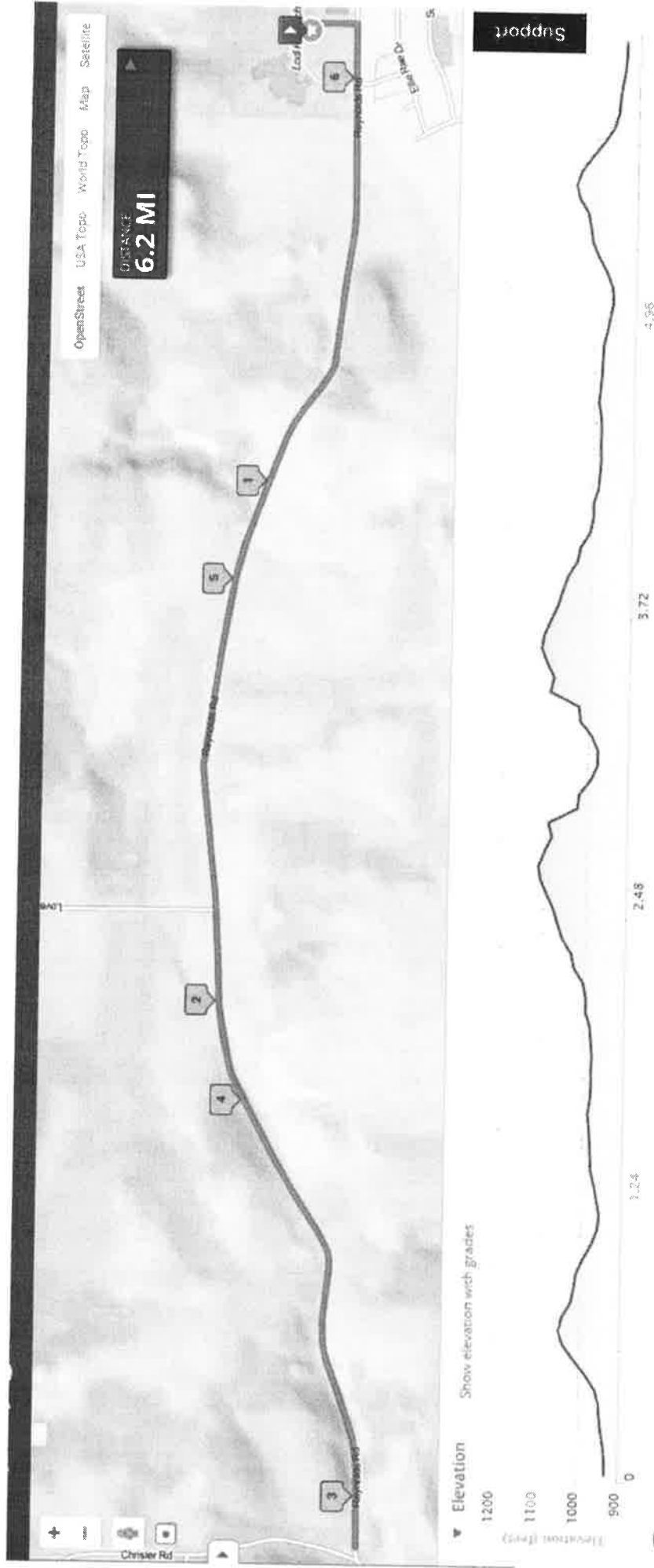
# LODI OPTIMIST'S one M@TH#R of a run 5K Run/Walk
