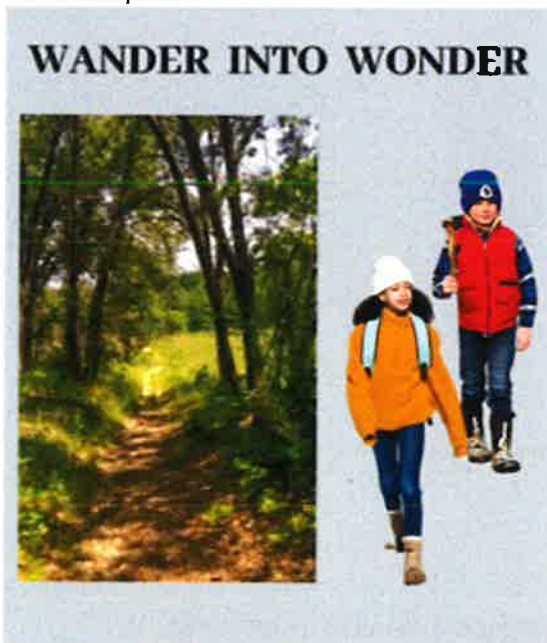
Steve,

Regarding the new design...

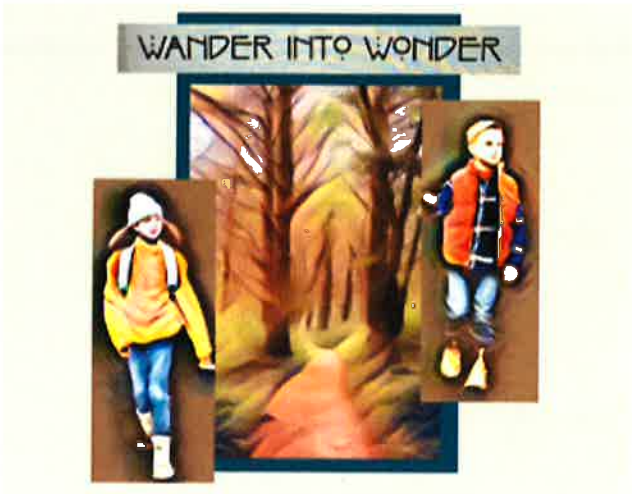

The basic photos are -

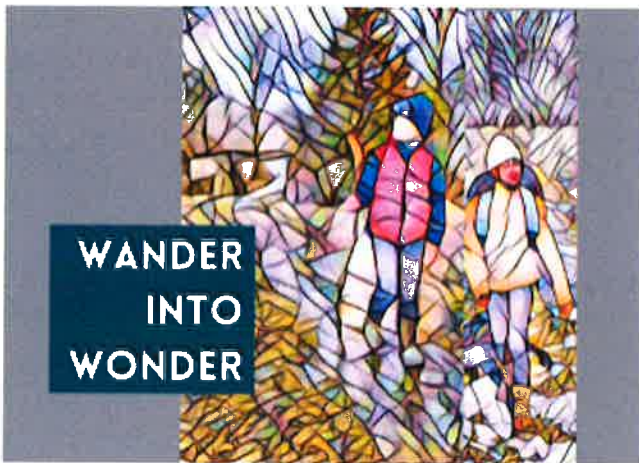


An "artistic rendering" might be closer to this -
